## **Coolum District Coast Care Action Plan 2015**

Coolum District Coast Care Group, trading as Coolum and North Shore Coast Care, is a volunteer based community group with over 150 members many of whom are active. CDCCG has been incorporated since 2000 and is well respected within the Sunshine Coast community. CDCCG projects include but are not limited to nine weekly bush regeneration sites from Stumers Dunes to Twin Waters, co-managing Coolum Community Native Nursery, monitoring marine turtle nesting and stranding between Sunshine Beach and Mooloolah River, monthly marine debris surveys in four sites, shares management responsibility for the protection and enhancement of the road reserve from Coolum Beach to Point Arkwright. By working with the community, like organisations and governing bodies, CDCCG aims to preserve the native flora and fauna in our district.
